Whilst two Land Drainage Operatives were unstrapping a ratchet strap from a trailer, one of the operatives sustained an injury to his mouth which resulted in broken teeth and a bleeding mouth. The Land Drainage Operative pulled the ratchet strap towards him when the strap was undone and not under any tension, the hook end then flew towards him and hit him in the mouth resulting in a broken front tooth and bleeding. The accident was logged in the Accident Record book and has been reported to the Health and Safety Executive, as under RIDDOR.
